Rethinking Mobility is a strategic plan to reduce automobile trips and manage parking demand while enhancing safety, convenience, and access for those walking, bicycling, and using public transit. The plan will focus on the following key areas:



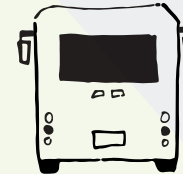
Developing programs and policies to reduce automobile trips and traffic congestion:

the City's General Plan 2025 recommends the development and adoption of a Transportation Demand Management (TDM) program to decrease the use of the automobile and reduce peak-period traffic congestion.



Improving mobility and access for walking, bicycling, public transit, ridesharing, and other shared mobility services (e.g., bikeshare and scooter share):

this will build on existing downtown parking management strategies, the Bicycle and Pedestrian Master Plans, and data from existing shared mobility pilot programs.



"Transit First" – improving public transit service and promoting it as a "first choice" mobility option:

this includes potential expansion of city-supported free bus routes and improvements to transit stops and amenities as well as programs to incentivize and promote transit use.

The City's Community & Economic Development Department is leading plan development with consultant support from Fehr & Peers.
